ABOUT MELKWEG

The only surviving factory building within the Amsterdam canal ring, Melkweg is a former sugar factory, turned milk (melk) factory. This historical building houses three concert halls, a cinema, a multidisciplinary room, and an exhibition space. With a reach beyond our venue, Melkweg events can also be found at external locations across the city of Amsterdam.

PRODUCTION INFORMATION

Once your show has been booked at Melkweg and you've received confirmation, you will be assigned a production manager (PM). This PM will be your contact to arrange all aspects of the advance. From this person, you will receive a time schedule, please read this carefully and confirm with the PM - **The deadline for any changes regarding the time schedule, get-in time, and number of local crew is one week prior to the show date.** On the day of show, it is very important that the agreed-upon schedule is not exceeded due to labour restrictions concerning the in-house staff's working hours. If the set-up and soundcheck time require more than 3 hours, a surcharge of €200.00 per additional hour will be applied.

All performers are subject to **ARTIST TAX**. Please read the following carefully: Performing artists can be exempt from artist tax if the artist proves they are a resident of a country with which the Netherlands has a tax treaty. So, we need a passport copy of all the members performing on stage.

For performing artists who are from countries without a <u>tax treaty</u>, the guarantee is subject to 20% tax. Dutch artists have to comply with regular Dutch income regulations. For these two groups (Dutch artists and artists from non-tax-treaty countires), €163 per artist is tax-free for expenses. By using the KVB TaxExemption Regulations, artists can apply for more tax-free expenses.

Therefore, copies of the passports of ALL performing artists need to be provided before the show to make sure their fees can be paid. **NO PASSPORT, NO PAYMENT!**

ON ARRIVAL

Please be aware that Melkweg is located in an old city, canals are common and the streets are small and often very busy. Proceed with caution!! For the easiest journey, follow the map below. Please do not deviate from this route!



Access to Melkweg parking on the Lijnbaansgracht is blocked by a traffic pole. To have this lowered, please either walk in or phone reception for assistance. At the same time, be sure to ask the reception for the required parking permit.

There is an additional pole located on Raamplein, plan your trip to avoid these times as the road is closed every: Thursday/Friday 22:00 – 6:00
Friday/Saturday 22:00 – 6:00
Saturday/Sunday 22:00 – 6:00

HEAVY TRAFFIC ROUTE & PERMIT

A specific driving route must be followed for all vehicles that exceed a weight of 7,5t (7,500kg). If this applies to you, notify production in advance. A special Heavy Traffic Permit is also required; this must be arranged with the production manager ahead of arrival.

PARKING

Parking availability is very limited; **all vehicles must be confirmed in advance with our production department**. Parking is reserved for tour buses and vans only, but we can provide details of nearby parking garages for private cars if necessary.

For optimal load out, closely follow the parking map that will be provided by the production manager, positioning tour buses in the designated spot on our parking strip outside the venue. Be sure not to block any doorways or bridges, these are fire exits. We are happy to supply sufficient bus power (2x 3 phase 16A CEEForm or 1x 3 phase 32A CEEForm). However, as we are located in a residential zone, it is not permitted to operate the bus's generator or stay parked overnight, due to local noise restrictions. If overnight parking is required, please ask the production department for alternative parking facilities.

PARKING PERMIT

The parking permit, available for large commercial (touring) vehicles, must be clearly visible at all times! Print the document you receive from the production manager and display this **inside** of the vehicle, in the front windscreen. The same goes for the permit our reception has. **Please return this parking permit upon departure!!**

Please note: Parking at this venue is managed by the local government, it is frequently checked and enforced with fines. Follow the instructions above closely, as Melkweg will not be liable for any potential parking fines.

A washing machine and dryer are available to use - free of charge, self-operated and at your own risk.

WATER

In an attempt to reduce plastic waste and help our beautiful planet, we provide water bottles for stage use only; every dressing room has its own filtered water point for refills. Please inform the production department in advance of how much stage water is required.

HEALTH AND SAFETY

Melkweg and all staff strive to create a safe and healthy environment. Please help us by using appropriate PPE (personal protective equipment) - in particular, steel capped shoes - when working in the halls.

All Melkweg shows are with NO BARRIER!

For the safety of the artists and our guests, stage diving and crowd surfing are strictly prohibited. If an artist is encouraging this behaviour, any resulting incidents will be the artist's responsibility.

We prohibit the use of CO2 in the Melkweg.

Melkweg has a zero-tolerance harassment policy! We are committed to creating a safe environment for all our staff, artists, and audience members. Any forms of bullying, harassment, or hate crimes of any kind, will not be tolerated.

We take appropriate measures against COVID-19, including providing a constant supply of hand disinfectant, ensuring that our ventilation system is always on, and complying with the latest local rules and regulations.
